DRAGON SPRINGS - FIRE DEPARTMENT REVIEW -

Chairman Vicaretti stated that the review was done earlier in the day, access to the property was granted by the Applicant. Town Engineer, County Coordinators and Chiefs from Cuddebackville Fire Department, were also present and notes were taken. Chairman Vicaretti went on to say that Cuddebackville Fire Department expressed concerns and plan to schedule a drill and would also like to test existing equipment and pump stations that are currently in place on the property to make sure apparatus is still operative. Al Fusco III, Town Engineer stated that their office was also present at the time of the inspection and they took notes on the concerns of the Fire Department, Emergency Management and County Coordinators and will have comments for the next meeting.
