Supervisor's Update By: Karl A. Brabenec, Town Supervisor

<u>RUMOR CONTROL:</u> I feel it is necessary to address various rumors that are being circulated about the Highway Department and Senior Shuttle. These rumors specifically are that the Town Board is "privatizing" the Highway Department and that the Senior Shuttle program is being eliminated. These rumors and statements are absolutely false. The present Town Board realizes the need and the importance of both our Highway Department and senior transportation in our rural town.

HIGHWAY DEPT: There are no plans to privatize the Highway Department. In January, I asked Councilman Art Trovei to provide us with a <u>study</u> on any potential savings we could realize with privatization of certain functions of <u>various</u> departments. We need to think out of the box and find ways to spend our tax dollars efficiently. This report should be released around March with recommendations for the Town Board to consider. I will be writing more about this in future reports.

SENIOR SHUTTLE: The program is not being eliminated, however, with the economic times that we all face, we must reform the way the program operates to make it more accountable to the taxpayers of the town. For over 20 years, the Deerpark Town Board has funded the Senior Shuttle. As of 2010, Deerpark taxpayers gave a \$52,000 subsidy to the Deerpark Senior Citizens Council, Inc., which is the organization that runs the Senior Shuttle program. We discovered that a portion of the town's appropriation, \$15,000 was going to a dispatcher that was working an average of 10 hours per week. The work included answering an average of eight to ten phone calls per day and signing checks for the

program. That amounts to \$28.85 per hour! While we appreciate and commend the work that this person had done over the years, the Town Board felt that this amount of salary was not justifiable for the work getting done and we deducted that amount from this year's allocation. We feel that the operation of the bus and the salary of the bus driver is very justifiable and that is why the Town Board allocated \$36,000 to run the program in 2011.

In addition, the Bus Driver of the Shuttle stated that 60 to 75% of the riders reside and pay taxes in the City of Port Jervis or live in Senior Housing facilities in Port Jervis. To this date, the City of Port Jervis does not contribute to the operations of the Shuttle Program nor does any of the senior housing facilities. That means that Deerpark Taxpayers are subsidizing a program that is mostly utilized by Port Jervis residents. The Town Board feels that this is unacceptable. Unless, these facilities or the city want to contribute, then the rider fares, which are \$5.00 per ride, should be lower for Deerpark residents and higher for Non-Deerpark residents.

ASSESSOR: Finally, I would like to congratulate our Assessor **Kathleen Smith** on her retirement 2/1/2011. Mrs. Smith has served the town for a little over 26 years. We all wish her many years ahead of health and happiness and thank her for her dedicated service to the town.
