LOCAL LAW NO. 3 OF 2011 A LOCAL LAW AMENDING SECTION 230-59 OF ARTICLE IX OF THE DEERPARK TOWN CODE ALLOWING THE TOWN BOARD TO APPOINT A VICE CHAIRPERSON TO THE TOWN'S ZONING BOARD OF APPEALS AND CREATING SECTION 64-3 OF CHAPTER 64 OF THE TOWN CODE ALLOWING THE TOWN BOARD TO APPOINT A VICE CHAIRPERSON TO THE TOWN'S PLANNING BOARD

Amendment Language. A. The following language shall be added to Section 230-59 of Article IX of the Deerpark Town Code after the existing second sentence of subparagraph A of the existing Section:

"A Vice Chairperson shall also be appointed by the Town Board."

B. The following Section shall be added to Chapter 64, Article I of the Deerpark Town Code as Section 64-3:

"In addition to the authorization set forth in Section 271(1) of the Town Law of the State of New York, the Town Board shall have the right to appoint a Vice Chairperson for the Planning Board."
