## RESOLUTION #11 OF 2011

### Resolution Slightly Modifying Resolution #6 of 2011 Regarding the Boundaries of Deer Park Election Districts Three and Five

**WHEREAS**, the Deer Park Town Board passed Resolution 6 of 2011 regarding boundary changes to Election Districts 3 and 5, and,

**WHEREAS**, a new state law passed in 2010 gives the sole authority to the Orange County Board of Elections to make and changes or modifications to town and city election districts, and,

**WHEREAS**, the Orange County Board of Elections have recommended making the following modifications to Resolution 6 of 2011, and,

**THEREFORE BE IT RESOLVED**, that the Town Board of the Town of Deer Park hereby recommends the alterations of the boundary lines of District 3 and District 5 to take effect during the 2011 election cycle (items in bold are amendments to the present boundary lines):

**District 3:** Beginning at the point of Neversink Drive (County Route 80) intersects the eastern bank of the Neversink River, thence southwesterly along the Neversink River to the point where the City of Port Jervis boundary line crosses said river, **thence along said boundary line of the City of Port Jervis to Academy Avenue, thence northeasterly along Academy Avenue encompassing both sides of the road until the intersection of Boxbaum Road, thence Northeasterly along the center of Boxbaum Road to the intersection of Peenpack Trail.** Thence easterly along the center of Peenpack Trail to its intersection with Martins Road, thence southerly along Martins Road to its intersection with Woods Road, thence southeasterly along the center line of Woods Road to the abandoned D and H Canal Bed, thence southeasterly along said bed to Taylor Road, thence southeasterly along the center of Taylor Rad to the center of US Highway Route 209, and the intersection with Neversink Drive (County Route 80), thence southeasterly along said Neversink Drive to the point of beginning.

**District 5:** Beginning at the intersection of the boundary of Sullivan County and the Orange and Rockland Utilities Right of Way, thence southeasterly along said right of way to its intersection with Prospect Hill Road, thence southwesterly along the center of Prospect Hill Road and Cahoonzie Club Road to Peenpack Trail, **thence southeasterly along the center of Peenpack Trail to it's intersection with Boxbaum Road, thence southwesterly along the center of Boxbaum Road to the intersection of Academy Avenue, thence Southwesterly along Academy Avenue encompassing both sides of the road until the**

**Orange and Rockland Right of Way.** Thence northwesterly along said right of way to NYS Route 42 to its intersection with Wilson Road. Thence along the center of Wilson Road to the center of the Orange and Rockland Utilities Right of Way. Thence along the center of said right of way to the Sullivan County Boundary line, thence northerly and easterly along the boundary line of Orange and Sullivan Counties to the place of beginning.
