Mr. Golden explained that there is a lot of details so he will go slow. He continued that he will go through what in general they are asking for and take small steps to start the SEQRA process. He further stated that he submitted a lengthy letter with the maps explaining what has been approved so far through the court process and what variances have been given by the ZBA. He added that the Planning Board has been asking for an overall site plan and this is it. He then went over the site plan stating that everything they are asking for is permitted by code, anything new was not constructed yet and that there were some things previously approved for use as something else and they would like to change the use or improve on the use or building.

Modifying:

- Meditation Hall previously approved change to Residence Hall
- A new Buddha house
- 3 new Gazebos
- A parking garage where an approved parking lot was
- A construction shed to be built to be used during construction
- Extension of a covered driveway, already approved dam and covered driveway just extension.
- Wastewater treatment plant
- Bioretention basin
- Elevated emergency access plaza-to be used to aid in fire control and fire fighting.

Town Attorney continued that according to the Town Engineers comments a number of items appear to require variances, he asked if they would like the Board to make a referral tonight or to wait the 30 days for response from involved agencies. Mr. Golden responded not at this meeting. Willard Schadt asked how far the Planning Board can go until they need to go to the ZBA, Town Attorney answered that once Lead Agency is established than a referral can be made. Town Engineer then went over the comments from Fusco Engineering stating that this is everything that they want to do, what has been done and what will be modified. He continued that the Planning Board will need Orange County Department of Health approvals, engineering reports on the wells, DEC approvals, SWPPP (Storm Water Pollution Protection Plan) for entire facility more details are needed, SPEDES permit or atleast the notice of intent, wetlands need to be delineated, traffic study and parking study need to be done, phasing of what projects will take place when, habitat study needs to be done, sign of from SHPO (State Historical Preservation Office) for archeological, fire department comments, 911 addresses for all the buildings, detailed erosion and site disturbance areas, and site visits will need to be conducted. Town Engineer added that this is a large project, the plans were thorough but need more details and to be cleaned up, mostly technical things. Chairman asked if PDF files could be provided along with the 2015 overall plan. Mr. Golden answered yes and added that they will wait the 30 days and come back at the April meeting.
