QUARRY MANAGEMENT – 131 ROUTE 6 – BUILDING SUPPLY YARD – John Fuller-Representative for Applicant

Mr. Fuller explained he was at last meeting for a pre-application, he submitted a completed application and maps. He continued this was an old lumber yard owned by Mr. Trovei, Quarry Management plans to buy this property and use it in a similar way to store materials. Town Engineer went through the comments from Fusco Engineering; distance from well and septic need to be shown, also area of disturbance, dumpster locations, and he also stated that the GML-239 needed to be done because they were on Route 6. Chairman asked for a written narrative explaining what they are going to do on the property and what materials and equipment will be on the parcel and location. John Fuller stated that is will be a storage yard for the materials, they will be recycling concrete so a crusher machine will be needed. Chairman added that with the equipment there will be noise and with the materials there will be dust that needs to be taken into account. Willard Schadt asked if the concrete would have the metal wire in it, what happens to that when crushed, John Fuller answered they pull out the large piece. Chairman Vicaretti stated that an equipment list and location on the property need to be provided. Town Attorney acknowledged that the narrative has to be in before the 239 is sent out.
