The Deerpark Planning Board met for their bi-monthly meeting on Wednesday, November 9, 2016 at 7:00 pm at the Deerpark Town Hall, 420 US Route 209, Huguenot, NY. The following were present:

Pledge of Allegiance

PINE GROVE PROPANE – TANK INSTALLATION – ROUTE 209 & LANDON DRIVE – Joe Jordan – Representative for Applicant from Povall Engineering

Mr. Jordan stated that they met with Cuddebackville Fire Department and have submitted the Fire Analysis. He continued that he has read the comments from Orange County Department of Planning and they have stated they are opposed to the emergency access onto Lakeview Drive. He stated that the Applicant could find an alternate means for access or if the Board had any suggestions they would gladly take them. Town Attorney acknowledged that to oppose a suggestion from the County Department of Planning they would need majority plus one. Mr. Jordan added that this was not a driveway they were proposing just an emergency access, using an existing trail that will now be maintained. Mr. Fusco stated that there is a possibility of approval through the County Parks Commissioner, County Legislature and Real Property before the Planning Board could approve. Mr. Jordan continued by saying that he has given Fusco Engineering a copy of the DOT application, he further stated he met with the Chief of Cuddebackville Fire Department to get specification for hose connections to put onto water tank in the back of the park. Theresa Santiago questioned if the D&H Canal is protected, Mr. Jordan acknowledged it was referenced as park land. Chairman Vicaretti stated that the public hearing was left open for written comment; the Board has received two which mirror the same comments made at the Public Hearing.

Motion to close Public Hearing.

He suggested that the Town get in touch with the County because this could increase the safety of the individuals in Oak Ridge Park. Chairman Vicaretti confirmed it could serve community purposes, Mr. Jordan stated he will call County directly. Town Engineer stated that they will review the new submission and if any new comments will let Board know. Town Attorney asked if the 62 days could be extended to make a decision, Mr. Jordan answered yes.
