NOTE: During the Reorganization Meeting (1/10/11), the Supervisor's appointment for Clerk to the Supervisor was Samantha Paliman and P/T Clerk is Marylou Maher.

<u>Cliff Robinson</u> made a presentation on the *D & H Trail* Grant Funding. He spoke with Dave Church at the Orange County Planning Department and found there is a grant available called the Greenway Communities Grant Program and there are between \$5,000 and \$10,000 available to help communities develop open space, economic development, associations, etc. The Town of Deerpark has already been approved as a Greenway area. This area discussed was outside the City limits of Port Jervis in the Town of Deerpark to the Mongaup and the Sullivan County line, but would be a three municipality grant, the Town of Deerpark as lead agency. This grant provides technical assistance and money to create trails. He clarified the money is up to \$10,000 for one municipality, however, it is a 50/50 grant. If the town gets a \$5,000, they need to pay out \$5,000—match it, then the town would get \$10,000 back. Discussion continued.
