Supervisor Brabenec reported receiving a communication from Harrison & Burrowes Bridge Construction about the demolition of six bridges on westbound I-84 structures over the Neversink and Delaware Rivers involving the Town of Deerpark and Port Jervis, New York, Matamoras and Westfall, Pennsylvania, and Montague, New Jersey. These bridges are over County Route 15 and Country Route 16. They will work with two shifts, 7 a.m. to 4 p.m., then the 2nd shift from 4 p.m. to 1 a.m. Monday through Friday. On Saturday they will use to make up lost time due to weather restrictions. They will begin in April and work through June. NYSDOT needs a written acknowledgement from the town. Glen Plotsky thought they would do the work anyway and thought they could respond with a thank you for the notification. Al Fusco, Jr. said the town may benefit from those exiting the interstate, but that the worst part will be in Port Jervis when East Main Street gets done at the same time. Discussion followed.

Mr. Fusco explained that DEC found no fault due to work on Black Rock Trail, but after two extensions, they need a new permit. A new permit will help us according to Mr. Fusco, and FEMA has offered \$90,000 for culverts. He got them up to \$180,000, but the

job is \$400,000. They have an extension to September 2015. This is the last project from those storms.
