New Business

Ed Hughson, Highway Superintendent asked for approval to put out two bids for a used sweeper and used bucket truck. Councilman Dean asked what the cost would be and he said it could be as much as \$45,000. Superintendent Brabenec said that they are at the 2% of the budget for equipment. There was \$125,000 budgeted, and he had only spent about \$2,900 so far. Mr. Hughson said they would see what the bids come in as. He said the bucket truck is just not safe anymore. Discussion continued. He will give copies to Flo and she will put the bids in the paper. They will open the bids the day of the next meeting. Councilman Dean asked how much was left in their budget and Supervisor Brabenec said there was approximately \$122,000.

Mr. Hughson then said there was communication that FEMA was issuing grants for sweepers and stuff like that. He said the supervisor had a copy of it as well. They could present it to Al Fusco to review and get a cost of what submitting a grant for a sweeper would be. The cost to submit a grant could be costly and they would not know if FEMA would approve the grant. The Supervisor will give it to their Engineer, Al Fusco to look over and advise.

Mr. Hughson mentioned that Mike Galligan, a local business man deals with blue stone and could maybe help the Veteran's with their Memorial. He will give both Floyd and Mr. Galligan a call about it.

Councilman Dean said he has heard a lot of good comments on the good job the Highway Department did on Wilson Road. *Mr. Hughson* said it was a three mile road and they tried a different process and the price of oil went up in July, so their costs were more than they anticipated. They had been approved to do Whitehead and Hartwood Club roads, but he may not be able to do Hartwood Club. They have had a lot of calls about pot holes on the Old Greenville Turnpike. More discussion followed.

<u>Supervisor Brabenec</u> gets phone calls asking for lower speed limits on certain roads and asked the Highway Superintendent for recommendations on how this would be handled. *Mr. Hughson* said that the state would need to be involved and the town would have to pass new resolutions. <u>Supervisor Brabenec</u> would begin with the Resolutions. The state could take years to make a change. He offered to look into it. Discussion followed. <u>Councilman Dean</u> asked about the new Highway Garage and Mr. Hughson said it is looking like August 15th may be the opening date. He needs to call Al Schock and get the septic in place.

Supervisor Brabenec read a letter regarding a dangerous building at 1045 Route 209 (SBL 22-1-43) from Al Fusco III (Building Inspector) and Code Enforcement Officer Robert Emerson, recommending demolition or removal of the structure and a copy of the Notice of Violation letter was delivered to the homeowner on May 27, 2014 was attached. The Supervisor said there was no response from the owner(s) and he asked the Town Attorney if the next step would be to schedule a public hearing. Town Attorney Glen Plotsky answered yes, the Town Board schedules a public hearing, the Code Enforcement Officer and Town Engineer report to you what steps are recommended to be taken, the property owner has the right to argue against what is being asked, the Town Board then directs action within a certain amount of time. If the homeowner doesn't comply, the Building Department arranges for the demolition/removal and the next tax bill will have the costs assessed on that property. The Supervisor added that they are made whole on that, if they are not paid. The Town Clerk and the Tax Collector submit paperwork for payment at the end of the year. Town Clerk Flo Santini stated the process is handled at the end of the year. She also said that they don't get a check from the county, but the county takes the amount owed back to the town off the overall taxes the town should pay the county.
