He was in favor of it. <u>Councilman Spears</u> added that this vehicle would update the list of vehicles to three 4-wheel drive vehicles good for emergencies. <u>Supervisor Brabenec</u> mentioned the other vehicle would be used by the Town Supervisor, Assessor, Building Department or councilmen. <u>Councilman Spears</u> thought a 4-wheel drive car is necessary for the town use. <u>Councilman Dean</u> agreed and encouraged them to purchase the car in Deerpark if at all possible.
