The Town does and shall maintain insurance coverage, presently with Haylor, Freyer & Coon, Inc. in the sum of \$50,000 plus an additional \$450,000.00 for the Town Supervisor and \$950,000.00 for the Town Clerk/Tax Collector to indemnify against losses through the failure of the officers, clerks and employees covered there under faithfully to perform their duties or to account properly for all monies or property received by virtue of their positions or employment, and through fraudulent or dishonest acts committed by the officers, clerks and employees covered there under.
