RESOLUTION 2 OF 2017

OF THE TOWN BOARD
TOWN OF DEERPARK, ORANGE COUNTY, NEW YORK

RESOLUTION FOR PAYMENT FOR FRANKE ROAD REPAIR

WHEREAS, the Town of Deerpark has previously secured Seventy-Five Thousand 00/100 Dollars (\$75,000.00) in additional funding through a grant from the Dormitory Authority of the State of New York (DASNY); and

WHEREAS, the Town of Deerpark verified that the funds previously secured as identified above could be used for various purposes including use by the Town of Deerpark Highway Department to improve and/or repair roadways within the Town of Deerpark; and

WHEREAS, Franke Road is a public highway/public road located in the Town of Deerpark, County of Orange, State of New York; and

WHEREAS, during the calendar year 2016, the Town of Deerpark Highway Department undertook to repair damage to the said Franke Road, pursuant to its obligations; and

WHEREAS, the Town of Deerpark Highway Department undertook to make said repairs, and in fact completed said repairs by resurfacing the said Franke Road; and

WHEREAS, the Town of Deerpark Highway Department expended a total of One Hundred Eleven Thousand Eight Hundred Fifteen and 76/100 Dollars (\$111,815.76) to resurface the said Franke Road; and

WHEREAS, the total of the additional funds available to the Town of Deerpark was in the amount of Seventy-Five Thousand 00/100 Dollars (\$75,000.00); and

WHEREAS, as a result, the Town of Deerpark was required to expend Thirty-Six Thousand Eight Hundred Fifteen and 76/100 Dollars (\$36,815.76) from its Highway Department Budget Line in order to complete the said repairs/resurfacing of Franke Road; and

WHEREAS, bills for the repair and resurfacing of the said Franke Road have been paid by the Town from its Highway Department Budget; and

WHEREAS, the Town wishes to utilize the funds available from DASNY as set forth above to offset the cost of said repair and resurfacing of Franke Road.

NOW, THEREFORE, BE IT RESOLVED AS FOLLOWS:

RESOLVED, by the Town Board of the Town of Deerpark, Orange County, New York, that the sum of Thirty-Six Thousand Eight Hundred Fifteen and 76/100 Dollars (\$36,815.76) be (re-)authorized to be expended from its 2016 Highway Department Budget Line in order to pay the remaining balance, after application of the DASNY Grant, for the completion of the above-described repairs/resurfacing of Franke Road completed during calendar year 2016.


