AGREEMENT FOR THE EXPENDITURE OF HIGHWAY MONEYS

AGREEMENT between the Town Superintendent of the Town of Deerpark,
Orange County, New York, and the undersigned members of the Town Board.

Pursuant to the provisions of Section 284 of the Highway Law, we agree that moneys levied and collected in the Town for the repair and improvement of highways, and received from the State for State Aid for the repair and improvement of highways, shall be expended as follows:

1. GENERAL REPAIRS. The sum of \$ 502,927 shall be set aside to be expended for primary work and general repairs upon 7.27 miles of town highways, including sluices, culverts and bridges having a span of less than five feet and boardwalks or the renewals thereof.

2. PERMANENT IMPROVEMENTS. The following sums shall be set aside to be expended for the permanent improvement of town highways:

(a) On the road commencing at Shinhollow Road
and leading to Neversink Drive (County Route 61), a distance of 2.19 miles,
there shall be expended not over the sum of \$ 142,350.00.

(b) On the road commencing at Lime Kiln Road
and leading to Old Greenville Turnpike, a distance of .96 miles,
there shall be expended not over the sum of \$ 62,400.00.
Type Cold In Place Width of traveled surface 18'
Thickness 2"

(c) On the road commencing at Old Greenville Turnpike
and leading to State Route 6, a distance of .65 miles,
there shall be expended not over the sum of \$ 42,250.00.
Type Cold In Place Width of traveled surface 18'
Thickness 2"


(d) On the road commencing at _____ Brandt Road _____
and leading to _____ Dead End _____, a distance of _____ 1.84 _____ miles,
there shall be expended not over the sum of \$ _____ 119,600.00 _____.

(e) On the road commencing at _____ Skinners Lane Development _____
and leading to _____, a distance of _____ 1.63 _____ miles,
there shall be expended not over the sum of \$ _____ 105,950 _____.




