Resolution # 8-2015 **Shinhollow and Gristmill Road Closure**

WHEREAS, Shinhollow Road and Gristmill Road are Town Roads owned by the Town of Deerpark, County of Orange, State of New York, (hereinafter "TOWN"); and

WHEREAS, the TOWN has received information that a bridge located on Shinhollow Road is in a state of disrepair, is failing and is potentially in danger of collapse; and

WHEREAS, the Highway Superintendent of and for the Town of Deerpark, EDWARD HUGHSON, has determined that the bridge is potentially unsafe and should be closed to vehicular traffic; and

WHEREAS, the Town Engineer, FUSCO ENGINEERING, has confirmed that the Town should take steps to divert traffic and prevent motor vehicles from crossing the bridge located on Shinhollow Road; and

WHEREAS, as a result of closing the bridge and placing of barriers to prevent access to the bridge, there is a new traffic pattern at the intersection of Shinhollow Road and Gristmill Road in the Town of Deerpark preventing through traffic on Shinhollow Road and preventing RIGHT turns from Gristmill Road onto Shinhollow Road; and

WHEREAS, there is currently a STOP sign only on Gristmill Road at the intersection with Shinhollow Road, with no traffic control on Shinhollow Road at the said intersection, the present design of which renders the use thereof potentially dangerous to the public; and

WHEREAS, in the opinion of the Highway Superintendent and Town Engineer, said intersection would be made safe by the installation of an Additional STOP Sign ON SHINHOLLOW ROAD at the corner of Shinhollow Road and Gristmill Road in the Town of Deerpark.

NOW, THEREFORE, the Highway Superintendent of and for the Town of Deerpark, EDWARD HUGHSON, is hereby authorized to install a STOP Sign on Shinhollow Road in the Town of Deerpark at the corner of the intersection of Shinhollow Road and Gristmill Road.


