## RESOLUTION #20 OF 2015

### Contract with Port Jervis/Deerpark Humane Society

WHEREAS, the Town of Deerpark, County of Orange, State of New York, employs a Dog Control Officer for the purpose of enforcing Laws of the State of New York and/or of the Town of Deerpark relating to the care, control, licensing and related issues of dog ownership and/or care; and

WHEREAS, there are occurrences where there are allegations of violation of Town or State laws and the owner of the particular dog cannot be located necessitating the seizure of said dog; and

WHEREAS, there are occurrences where dogs must be removed from the care and custody of their owner for the safety of the animal necessitating the seizure of said dog; and

WHEREAS, there are occurrences where dogs must be removed from the care and custody of their owner for the safety of the public or other dogs necessitating the seizure of said dog; and

WHEREAS, the Town of Deerpark does not own or operate a facility for the care of dogs, and as a result must contract with a service provider to provide for the care and custody of dogs who have been seized because their owner cannot be located, or the safety of the dog requires removal/seizure, or the safety of the public or other dogs requires removal/seizure; and

WHEREAS, The Humane Society of Port Jervis/Deerpark Inc., a not for profit corporation is such a service provider located in the Town of Deerpark, capable of providing care and custody for dogs lawfully seized by the Dog Control Officer of the Town of Deerpark.




