**A LOCAL LAW EXTENDING THE TERM OF OFFICE**  
**FOR THE TOWN CLERK FROM TWO (2) YEARS**  
**TO FOUR (4) YEARS**

Pursuant to Section 24-a of the Town Law of the State of New York the term of office of Town Clerk of the Town of Deerpark, Orange County, New York, is extended from the current two (2) year term to four (4) year term. This Local Law shall be submitted to a mandatory referendum at the next general election held in the Town after the adoption of this Local Law by the Town Board.

The intent of this Local Law is to extend the term of the aforementioned elected official of the Town commencing with the individual elected at the next general election after the mandatory referendum. Therefore, the individual elected to the position of Town Clerk after, but not including the general election of 2010, shall serve for a four (4) year term.

PLEASE TAKE NOTICE TO THE EXTENT THAT THIS LOCAL LAW MAY CONFLICT WITH APPLICABLE PORTIONS OF THE TOWN LAW OF THE STATE OF NEW YORK, IT IS THE STATED INTENTION OF THE TOWN TO EXERCISE ITS AUTHORITY TO SUPERSEDE AND AMEND, AS GRANTED UNDER THE MUNICIPAL HOME RULE LAW OF THE STATE OF NEW YORK, SECTION 10.
