Al Fusco referred to his technical memo, dated September 25, 2013:

- 1. Oakland Valley Road is a county road and therefore, General Municipal Law 239 must be addressed before action.
- 2. New and old acreage on lots is to be cleared.
- 3. New deeds reviewed by engineer and attorney
- 4. Board comments.

Al Fusco said that the applicant is improving a non-conforming lot. He said that the acreage, printing on the map, is conflicting between the tax lot and the "subject parcel", the acreage numbers do not match. He asked that Mr. Breitweisers' surveyor needs to clarify the numbers. He also said that the words "contains 5.39 acres plus or minus to be joined..." needs to be eliminated and replaced with the wording "proposed acreage contains 6.51 acres." He also asked that the applicants' surveyor review the tax map, to make sure that it is correct.

According to GML 239, because the County needs 30 days to respond, the applicant will be scheduled to appear before this board again on November 13, 2013,

The board instructed the applicant to have his surveyor gets copies of the new maps, with the requested changes, back to the board, and town engineer, whom his surveyor can contact directly.
