Councilman Hoovler gave highlights of where they were going: The revenues and expenses came in right where they projected; they were within their limits on almost all their budget lines. Moving forward with their next three year plan, they need to do better with managing their cash flow at the town level. They want to focus this next year on getting the town into the bond market so they have the ability to go into the private sector and avail themselves to banks and shop around, and not being limited to borrowing off one lender. The bond rating requires certified financials as well as independent audit of town finances. It is quite costly, and needs to be discussed. FEMA money and 12.5% of FEMA share that ultimately falls on the town. He reported that the town is still in debt, but doing decently. Overall, the town is doing well with their plans. Though they were \$858,000 in debt, they are doing substantially better than many towns that have surpluses. He credits the monthly financial reports that come out and the Supervisor and Bookkeeper who keep things on track. They were hoping to find more money this year for Parks and Recreation as well as more money for a Senior Project. He should have a plan in a couple of weeks. Supervisor Brabenec thanked Councilman Hoovler for his work on this plan.

He called the FERC and talked to the gentleman handling the Minisink project and he said they absolutely were not considering the Town of Deerpark. The only applications and alternatives had to do with Minisink. This resolution would allow them to request additional information or oppose the environmental issues. He thought it was appropriate to put them on notice that they have environmental concerns.

Harriet Space Park Improvements Discussion

Councilman Spears reported that the Recreation Committee needs to update the park to get it into safety compliance with NYMIR and make improvements to help the organizations providing recreation services in town, so they don't have to duplicate their services. Besides needing to raise money and find volunteers, they plan on doing what has to be done, such as install safety rail on baseball fields before Spring so the Little League can use them. He has already discussed this with the Parks Maintenance Supervisor, Ed Hughson. They have already purchased new aluminum benches for the dug outs and benches for the spectators. They may need to place security cameras there due to past vandalism. He asked for permission to look into getting cameras. Councilman Hoovler was all for that and thought they used to have a gate and thought they should have a gate there too. Councilman Spears wrote it down and thought they could check with Orange County and Councilman Hoovler added he had spoken with them and was told they could do whatever they wanted to do. Councilman Spears reported purchasing new combination goal posts for the Youth Soccer and Football Leagues and they have plans to build another field in the future that could be used by those leagues. They want to facilitate the youth organizations in town so they don't have to duplicate their services. They would be willing to take any questions. Councilman Dean asked if they would be able to use wireless cameras that would transmit a signal to Town Hall. Councilman Spears checked into it and they could have a monitor and/or a tape that would run for a year. Councilman Dean asked if they put cameras, why not also have cameras cover the fuel near the Town Barn. Councilman Trovei will bring back information to the Town Board that he is currently gathering for his own business. More discussion continued. Councilman Spears will report back when he has gathered more information. Councilman Hoovler said that Al Fusco had already prepared a rough diagram for them. Councilman Spears added they would be needing new picnic tables for under the pavilion. Councilman Hoovler said they were also trying to put some money aside to do some work in Building No. 2 for the seniors. Supervisor Brabenec said they have an allocation in their Building and Grounds funds that they could utilize for that. Discussion continued. <u>Supervisor Brabenec</u> offered to get some estimates from different contractors in regards to Building No. 2. Councilman Spears asked him to set up a meeting with the seniors to ask what they want. Councilman Dean thought they should verify the electrical/heating system in that building is safe, and then go from there.

They will work with the residents to apply through the town for grant money to fix up their homes. They will need a lot of guidance and help with that too. The Tax Collector asked him to announce that many in the Cuddebackville area had their tax bills returned to the town. One problem is that the post offices for Cuddebackville and Huguenot are merged right now. There is a new way to get your tax bill online also. There is a link on the town website. Lastly, he thanked the board and thought they had been great the past two years. He was looking forward to the next two

He tried to give 100% every day and try to help out all the people he can. He definitely finds it the most rewarding job he has ever had. He looks forward to serving the resident the next two years. Finally, GO GIANTS.
