PLANNING BOARD MEETING JULY 8, 2020 continued -

OWEN WRIGHT – OAKLAND VALLEY ROAD – PRIVATE CAMPGROUND – SITE PLAN REVIEW – Owen Wright-Applicant

Town Attorney disclosed that he has met with Mr. Wright and further stated that the checks to pay escrow did not clear with the bank. Mr. Wright explained he had postdated them for the 1st and they went in on the 26th, but he can get another check. Chairman acknowledged that this project has been before the Board, Mr. Wright stated that yes but now it has been drawn up as a private campground, with three small cabins, there will be a common area with a pole barn and a fire pit. Chairman asked if he received the comments from Fusco Engineering, Mr. Wright stated that he sees no issues with them. There is no lighting and he will get the driveway permit. Town Engineer explained that this is a permitted use in the RR (Rural Residential) Zone he added that all recreation areas need to be 200ft from the property line and screened. Also, there is no public address system and sanitary code needs to be in accordance with Orange County Department of Health. He also stated that details on the water and septic need to be presented, Owen Wright acknowledged that there is an existing well on the lot, Mr. Fusco stated it needed to be tested. Mr. Wright stated there are new plans that have 3 separate septics. Town Engineer stated that a driveway permit needed to be filed with the County, Mr. Wright acknowledged that there is an existing driveway, Mr. Fusco added that it needed to be signed off on for site distance. Town Engineer asked what the maintenance shed was for, Mr. Wright replied for lawn equipment and boats, Mr. Fusco stated to show what it will look like. He added that they will review the new maps and submit a new list of comments. Town Attorney explained that no final plans have been reviewed so GML-239 could not be done yet. Mr. Wright asked about scheduling a public hearing, Town Attorney answered that first the 239 needed to be done that was a 30 day wait time then a public hearing could be done.

Motion to declare intent to be Lead Agency.

Motion made by Theresa Santiago, 2nd by Craig Wagner to declare intent for the Town of Deerpark Planning Board to be Lead Agency for SEQRA purposes.
