Al Schock asked, why is this a lot line change and not a subdivision?

Mr. Plotsky answered that it should be a subdivision, because it's not being annexed into another municipality. He said that he doesn't know what lot line is being moved, and he said that he thinks that it is adding a lot line to separate the two lots. He said at this time, the board either consider conditional approval, or the board could request an inspection from the Building Department to address that second issue raised by Mr. Terpening, or the board could just adjourn the matter for further consideration and think about it.

Theresa Santiago asked about the dumping, is it a dump site?

Gary Flieger answered that there are a couple of cement forms there, but not even near a dump site.

Al Schock asked if the subdivision should be granted conditionally based upon the purchase by the Land Trust and ultimately being transferred to the State, so that the board is not agreeing to create a landlocked parcel.

Gary Flieger said that he would consent to the above suggestion by Al Schock being added to the motion.

Hunter made a motion to grant conditional approval based upon submission of a licensed survey, for approval by the Town Engineer, and the filing of a metes and bounds description with drafted deeds for the Town Attorney's approval, and subject to an inspection to be conducted on the lot line by the Building Inspector to determine whether or not there has been any dumping, and if there are any violations on the property, the approval would be subject to those violations being corrected and that the purchase by the Orange County Land Trust be ultimately transferred to the State, and payment of all fees. Santiago second.

Mr. Flieger was told to get the survey to the Town Engineer as soon as possible, so that he can review it, and then the applicant can be added to the next available agenda.
