The Aid requested a meeting with him and the Building Department. They sent him a letter saying they need to have a written release from the New York State DEC, or they cannot issue any permits. They are waiting on the DEC. She inquired of funds from the county that come for the community or capital improvement and she wondered if a small amount could be set aside for the Smart Growth Neighborhood Improvement with plantings or walkways in this hamlet in the future.

Motion to Approve Inter-Municipal Agreement Between Port Jervis and Town of Deerpark – Shared Taxes

Motion by Ken Smith, 2nd by David Dean to approve the Inter-Municipal Agreement between the City of Port Jervis and the Town of Deerpark for shared taxes of annexation properties.

Discussion: Councilman Dean asked if there was a number and Supervisor Spears said no, but could say it was 50/50. Depending on whatever the future ratables are going to be, the town will receive half of them. He said their part of that is to maintain a road that will be built and paid for by the developers and then they will keep it plowed, gutters and sanding, etc. The city will get other things besides their half of ratables, they will receive the sewer fees, the water provided and police protection as their part of the ratables. The Deerpark police will travel the roads and handle traffic violations. Right now, the properties to be annexed: one is raw land and the other has buildings that mostly have been demolished. The proposal for one is a light industry and the other is a proposal for hotel and restaurant. So, substantial ratables could come into play now. One is ready to go, the other has to be done by Port Jervis.
