YMCA Summer Program - by Jessie Wells and Jennie Caiafa. They offer good safe programs for children ages 4-13. They come to camp every day. They are provided a hot meal and two snacks along with educational programming—building character in youth around this area.

Supervisor Spears stated that for those who don't know, the Town and YMCA have provided this camp opportunity at a reduced rate through the Recreation Fund for the Town of Deerpark. It has been a huge success. This world class camp is in our area and they served about 130 Deerpark residents a week last year. They had 86 returners last year and 44 new campers per Jennie Caiafa. New families are now calling them to find out it. Supervisor Spears asked how many weeks they can go. Jessie and Jennie replied two weeks. Jennie said they have a proposal that has worked really well. They propose four staff at nine weeks, one of training and eight weeks of camp, costs are the same rates as last year. The cost to Deerpark residents is \$85 per week for two weeks. Though their costs have risen, they kept the same rates for Deerpark. Their normal cost is \$240. Deerpark is receiving a very big discount. They will come and do the sign ups with Tippy and Flo. Ratios of campers per counselor was explained. They are careful to stay within those confines all the time. They are proposing signups for May 1st, 5-7 p.m.; May 2nd 12-2 p.m.; and May 8th 5-7 p.m. They will also prepare a flyer for the town to post. A lot of people signed up later and later, but they want to streamline the registrations. Jennie described the line up outside the Town Hall during registration. Discussion continued.
