Decommissioning Agreement:

The *Town Attorney Glen Plotsky* explained that before obtaining a building permit, the applicant for a commercial solar facility has to supply the town with protections in the event that at the end of the term, or at any point when the facility is no longer being used, so town would have the wherewithal to remove the facility if they don't. They could use insurance bonds, a letter of credit from a financial institution where the applicant and town engineer agree on a dollar amount. He then said that for Sparrowbush NY 1, LLC the amount is \$80,500 and Sparrowbush NY 2, LLC the amount is \$42,550.00. With those cash amounts will be provided by the town and the town would need to create an interest-bearing account on behalf of the applicants. Supervisor Spears verified that those monies would be held in escrow for fifteen years, the same as the solar pilot and the attorney said at least. Councilman Dean asked if they decide to sell that facility to another entity, would they transfer that? The attorney said that whatever entity they deal with will have to have the decommission amount. Some more discussion continued.
