#### Public Comment:

<u>Pat Longobucco</u>, Attorney from the law office of Shapiro, DiCaro & Barak located at 250 Mile Crossing Blvd, Suite 1, Rochester, NY 14624. Mr. Longobucco said this property was the subject of a foreclosure action of their firm by the attorneys representing Merchant Bank. They were notified by Mr. Fusco that this property was subject to a fire. He asked for 30 days so the bank could have the structure inspected so that the banks attorneys could come back on August 12<sup>th</sup> to either explain why it is not a dangerous building, explain how they're going to deal with the fact that it is a dangerous building. <u>Supervisor</u> <u>Brabenec</u> stated that the Building Department had attempted to contact this bank on numerous occasions because there is rotten infestation there going on to neighbors properties, there is the stench of garbage, it is a disgusting sight over there and the neighbors are suffering. He didn't think to wait 30 days was acceptable. Mr. Longobucco said they were just assigned this file with the post-foreclosure sale. Conversation continued on how they could address these problems.

New Business

<u>Supervisor Brabenec</u> reported having tabled the Local Law #3, which is the Road Protection Law at the July 8<sup>th</sup> meeting when they had the Public Hearing. This is for major projects in the town, where they would have to put up a performance bond in order to proceed. This is for the purpose of protecting our roads. <u>Councilman Spears</u> hadn't read the public comment or actually participate in any discussion, so he wanted to ask for an extension to the next meeting so he could get up to speed. <u>Councilman Dean</u> asked if this was passed on a Tuesday, would it start on Wednesday. He said that any project that is in the works and the follow the procedure and it becomes law; does it apply to the project in the works at that time? Al Fusco, Engineer explained how the law would impact the road. <u>Councilman Dean</u> asked how they could ascertain what part of the project has to comply with it. <u>Councilman Dean</u> thought this did not have to be decided on that night, but could be postponed to the next meeting. Discussion followed.

#### Motion to Table Local Law #3 of 2013 - Road Protection Law

#### **MOTION CARRIED**

A report on the proposed *Highway Garage and Senior Building* was presented by Al Fusco, Jr., the town's engineer. Al explained particular information as follows: the garage will be built directly across from the existing Highway garage and includes a 7,680 square foot building; 5,000 of which will be highway garage and the balance of 2,680 will be the senior center. The bids were opened June 13, 2013 for General Contractor, Plumbing, HVAC and Electric for a total of \$862,857.00. (A copy is attached to the official minutes.) <u>Councilman Spears</u> asked about the terms for the bond and if they need to be set that night. <u>Supervisor Brabenec</u> mentioned that the length of term determines how much is paid per term, however there would be less paid in interest. He went on to state 3.75% is the 15 year interest rate and 4.25% is the 20 year interest rate. <u>Councilman Spears</u> recommended the 15 year term. <u>Councilman Dean</u> clarified that the payback on the amount borrowed would be \$760,570, when the debt service is included it is a million dollar building. He also inquired about the \$1,012,000.00 doesn't include the \$225,000, so it really is close to \$1.3 million dollars. He thought if they authorized the bond situation, would there be permissive referendum possible. <u>Supervisor Brabenec</u> said there was an option for a permissive referendum after the resolution is adopted and there would be a 30 day waiting period. It could be requested with a petition with a certain amount of signatures. <u>Councilman Trovei</u> asked if he knew what that amount was and the Supervisor thought it was about 5%. Discussion continued.

#### Motion to Approve Demolition of Unsafe Structure at 15 Old Road, Cuddebackville, NY SBL 21-12-6

Motion by Karl Brabenec, 2<sup>nd</sup> by Gary Spears, that structures SBL 21-12-6, 15 Old Road in Cuddebackville, New York, based on recommendation of the Building Inspector, be deemed as a nuisance and a hazard to the community and deemed unsafe by the Building Department of the Town of Deerpark. Furthermore, the Town Board recommends that the town demolish the structure and place the amount due for the demolition on the property owner's taxes.

<u>Supervisor Brabenec</u> consideration of final draft of subdivision law amendments. <u>Councilman Hoovler</u> asked the Board to table that and <u>Supervisor Brabenec</u> answered that unfortunately they could not because they would lose their grant. Town Engineer, Al Fusco stated they need to submit to the UDC by the 26<sup>th</sup> as they did with the zoning. They took some time after that to finalize the local law. It still got the grant so to speak, but it was enough to submit a final draft to secure the grant. Discussion clarified that this would be a revision to their subdivision local law. <u>Supervisor Brabenec</u> clarified that when they went through the zoning changes, there were recommendations the board wanted to see that had to do with the subdivision law amendments. Mr. Fusco stated that when they submitted the grant in August, they told them the project would be \$18,500.00 and they requested \$5,000.00 of grant money. They gave the town \$3,600 in grant money. At this point, he could not give an exact cost but thought it would be substantially less than \$10,000.00 that they actually spent. The supervisor added that when they applied for the UDC grant, they had to come up with a final draft to submit to the UDC before July 26, 2013. In authorizing the grant, they were authorizing the work to be done to put a final draft together for this. Discussion continued. <u>Councilman Hoovler</u> said he would withdraw his request for tabling the amendment.

He said by August 16, he will have everyone's information and the completed project should be to the Board by the beginning of September and they will have about a month to debate that. By the end of September, they would look at adopting a Preliminary Budget for 2014 and that is then reviewed by the NYS Comptroller's Office during October. The Public Hearing on the Preliminary Budget would be the first Thursday in November, November 7<sup>th</sup>. An adopted budget must be in place by November 20, 2014. Same process as always. <u>Councilman Spears</u> recommended using words like 'need list' or 'fiscally responsible list'.

**Closing Board Comments** 

<u>Councilman Spears</u> thought they all deliberated long in their minds and hearts over the building and he was happy to see they made an affirmative decision to move forward. Over time, it would prove itself out to be a good investment for the people in Deerpark. They do have an opportunity to speak to petition to referendum if they so choose, but asked that they look at all the numbers they have had a chance to look at before they make a decision. He thought it was a sound decision and good for the community in the long run.

Councilman Hoovler asked everyone to be safe on the river.
