Presentations/Communications

Virginia Dudko – Representative for the Upper Delaware Council Scenic Byway She spoke about the 100<sup>th</sup> Anniversary of the National Park Service. The Byway has been participating in the 100 mile paddle. They have been voted the 2<sup>nd</sup> most scenic byway in the entire United States. She thanked the town for the donation every year. They are updating their website. In 2004, the federal government allocated \$539,940 for a visitor's center on the byway. That funding was lost. The county lost enthusiasm. They would like to have it at Fort Delaware. The money has been transferred from federal to state. They want to initiate "adopt a highway" along the byway. She explained the specifics. More information and discussion followed.

Florence Santini – Town Clerk reported on the 9/11 Ceremony. She said her office was getting letters out for guests and supplies. On Sunday, September 11<sup>th</sup>, the 15<sup>th</sup> anniversary service will be here at the Town Hall. She asked the Board to approve her to receive donations. Home Depot will come to do the black mulch and bring mums. The town only pays for the bows, and that was all from previous donations. Sparrowbush Fire Dept. will change their usual Sunday breakfast to join the ceremony. As long as Flo is here, no one will ever forget. She thanked the board for permitting her to have this. After the service, refreshments will be served in the Senior Center. She also announced the Honor Flight on Saturday, September 10<sup>th</sup>.

The bridges are 95% covered and the culverts are 100% covered.



# **AUTHORIZING SUPERVISOR TO SIGN AGREEMENT WITH "TCPN"** FOR THE NATIONAL IPA PURCHASING NETWORK

A RESOLUTION OF THE TOWN OF DEERPARK, HUGUENOT, NY, APPROVING THE TERMS AND CONDITIONS OF AN INTERLOCAL AGREEMENT BETWEEN THE REGION 4 EDUCATION SERVICE CENTER, LEAD AGENCY FOR THE COOPERATIVE PURCHASING NETWORK ("TCPN") PROVIDING FOR COOPERATIVE PURCHASING PROGRAM FOR GOODS AND SERVICES; DESIGNATING THE SUPERVSISOR, AS OFFICIAL REPRESENTATIVE OF THE TOWN OF DEERPARK RELATING TO THE PROGRAM.

WHEREAS, the Town of Deerpark has been presented a proposed Inter-local Agreement by and between the Region 4 Education Region 4 Education Service Center, lead agency for The Cooperative Purchasing Network (TCPN), and the Town of Deerpark found to be acceptable and in the best interests of the Town of Deerpark and its citizens, are hereby in all things approved.

WHEREAS, the Town of Deerpark of Huguenot, NY pursuant to the authority granted under Town of Deerpark, desires to participate in the described cooperative purchasing program, whose lead agency is Region 4 Education Service Center, and in the opinion that participation in the program will be highly beneficial to the taxpayers through the anticipated savings to be realized.

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD MEMBERS OF THE TOWN OF DEERPARK OF HUGUENOT, NY.

Section I. The Terms and conditions of the agreement having been reviewed by the Board of the Town of Deerpark and found to be acceptable and in the best interests of the Town of Deerpark and its citizens are hereby in all things approved.

Section II. The Supervisor and Bookkeeper of the Town of Deerpark under the direction of the Board of the Town of Deerpark is hereby designated to act for the Town of Deerpark in all matters relating to The Cooperative Purchasing Network including the designation of specific contracts in which the Town of Deerpark desires to participate.

Section III. This resolution shall become effective from and after its passage.
