Supervisor Brabenec said they have a new Senior Center that will be officially dedicated in the next couple weeks. The Senior Center is put together with the new Highway Garage. It's a new infrastructure that has been sorely needed for over a decade. The board was able to accomplish this without having to raise taxes and with good financial planning. The Senior Center will be an asset to the community for probably the next 50 to 60 years. This board has thought long and hard about naming the Senior Center after someone who was local, very active and had done a lot for the Deerpark seniors. All the board is in agreement with the proposal and will present it tonight. After they vote on it, they will rename to the Deerpark Senior Center as the Robert W. Cunningham Senior Center. Though Bob is no longer alive, his wife Joan and son Cort and family were there. He then read the resolution.

She showed a short video demonstrating the persecution by the Chinese Communist party.

New Business

<u>Supervisor Brabenec</u> explained they currently have a Court Attendant who recently took training for fire arms and peace keeping. However, Civil Service has an issue with granting a peace officer status to carry a pistol in the courtroom for

security. The Supervisor checked into a Constable position within the town that would be a Court Constable under direction of the courts and not the police department. A Constable is a Peace Officer. State law allows you to have both a police department and a Constable position. Attorney Glen Plotsky also checked on this. He would like to create a Constable position and then appoint the Court Attendant to the Constable position effective immediately and submit it to Orange County Civil Service. Councilman Dean confirmed that this position would apply solely to the Court. Supervisor Brabenec stated that the Constable is a peace officer and civil position, not criminal. If a person needed to be served, he could be used for that. The Constable position is much like the DCO position. Councilman Dean asked for the limit to this position and asked if it would not grow beyond the parameter of the court setting. Supervisor Brabenec said they could use him for security for a town board meeting for an example. Councilman Trovei asked how many hours for this position. The Supervisor said it will be part time for the hours needed. Court is Tuesday and Wednesday for a few hours a night. Councilman Spears asked if he has been trained with the Taser and the Supervisor said he has not, but that would be an additional training possible. Councilman Dean asked for specific wording about no more than 20 hours a week and that he is under the control of the court.

New Building Report

Al Fusco, Jr., Town Engineer said he was very pleased to report on the Robert W. Cunningham Senior Center. He offered congratulations to the Cunningham family, saying he was a real gentleman. The project is going extremely well. They were completing many of the projects. The kitchen and bathrooms are just about complete. They hope to have it ready to open the week after next. The Highway Department will begin working on the site and install guard rails and concrete pads in front of the doors. Councilman Dean asked about whether they received the curb cut from the state and Mr. Fusco said they just received a letter that day. They had one small issue and wanted them to move it down a little bit. They didn't give them a variance because of the existing pole. They're about 95% there.

Florence Santini, Town Clerk gave an update on the 9/11 Service reporting how Home Depot has once again spruced up the place with new mulch and mums. They have donated so much to the town with the 9/11 and the new senior building. Both Laura Mosca and Bert Eagle worked on the front and made it look so nice. She hoped everyone got her email message about purging records that belong to the town and that they should bring what they have to her and she'll make sure it gets shredded. The 9/11 service is the 13th memorial service and begins at 8:30, refreshments will follow. The school choir will be there with some dignitaries, EMS, Police, etc. The food is all donated. Supervisor Brabenec said it was one of the best memorials in the county, if not the best. He thanked Flo for her hard work. He added that the town appreciates all she does.

<u>Supervisor Brabenec</u> mentioned they had bids on a 2006 Chevy Impala with four doors and about 160,000 miles. The top bid was for \$860.00. They could accept or deny the bid. If they deny the bid, they hold on to the Chevy and re-bid it on Auctions International.

Councilman Dean asked how many more years they need to run their budget past the comptroller's office and the supervisor responded until 2018—and they have been given top marks for what they are doing. He would want to do it voluntarily because it is a second set of eyes.

Closing Board Comments

Councilman Spears congratulated the Cunningham family on the naming of the new Senior Center. They couldn't come close to listing all that Bob had done, but for a number of years he did good for the residents of Deerpark. It was an honor for them to name the building after him. He thanked Norma Schadt and her assistant for the work they do and how they keep the history alive. He acknowledged it takes a lot of work and offered kudos to them. He thanked the Falun Dafa presenters and all those who came out.

<u>Councilman Trovei</u> congratulated the Cunningham family and said he had the privilege of working with Bob the first time he was a councilman in Deerpark and it was well deserved. He thanked those for the presentation and commented on how sad it was that on this planet there can be such atrocities done to one another. He said that the allowance of aborted babies throughout America and China is heavy on his heart. He was sorry for their plight.

<u>Councilman Dean</u> congratulated the Cunningham family and said it was deserved honor. He said Bob did many, many good things for this town so his legacy continues with the new building. He also thanked Falun Dafa for their presentation saying it was eye opening and revealing and unfortunate.

<u>Councilman Smith</u> knew Robert and congratulated his family for that honor being bestowed on them. He expressed thanks for the presentation regarding their plight over the years, he hoped the world listens.

Supervisor Brabenec reminded everyone that tomorrow was the Primary Election Day. There was a primary for each of the Republicans, Democrats, Conservative and Independence parties in the Town of Deerpark. All registered voters could vote from 6 a.m. to 9 p.m. He said he had the privilege of running for council and working with Mr. Cunningham for two years and he learned from him as a new councilman and how to improve the town. He was a good person to talk to and he sure appreciates everything he's done. As far as the presentation is concerned, he thanked them for bringing this information to them and thought they should go to other town boards and city councils and let a lot of people know and have open communication. He promised to be an advocate to anything he can do to spread the word to stop those atrocities.
