I am pleased to inform you that the above referenced property was listed **September 18, 2017** on the National Register of Historic Places. As you may know, the National Register is the nation's official list of properties worthy of preservation. Listing on the National Register recognizes the importance of these properties to the history of our country and provides them with a measure of protection. *In addition, owners of income producing properties may qualify for federal and/or state income tax benefits. Homeowners in qualifying census tracts may qualify for state income tax benefits for approved work.* Properties owned by municipalities and not-for-profit organizations are eligible to apply for state historic preservation matching grants.

Highest bid awarded to #5 Greene Lumber Co LP. Agent from DHW Forest Consulting, Laurie Raskin will notify bidders of results and execute a contract to the awardee, Greene Lumber Co LP to be signed by the 18<sup>th</sup> of October, 2017 with payment of 50% to the town upon signing and 50% when cutting starts. DHW Forest Consulting will receive 15% of awarded bid as commission. Bid Awardee must supply proper insurance before start of the project and give a start and finish date of timbering. Contract states must be finished within 18 months and not to exceed March 27, 2019.
