<u>Supervisor Spears</u> clarified on Page 3 - 1620.1 Building and Grounds that there was a mistake in the P/T Floating Clerk position who is paid hourly and only gets paid for hours worked. The excess is in case of emergency needs for a clerk.

<u>Supervisor Spears</u> explained the need for an additional \$15,000 for the Police on Page 5 to get into the shared buy with Port Jervis Police and Pike County Police Agency and the Delaware Valley Police Agency to purchase a firearm simulator train, which will save the town time and money in necessary training. Deerpark's share is \$15,000 under A3120.2.

#### Motion to Change Line Item A3120.2 – Police Equipment from \$90,000 to \$105,000

Motion by Arthur Trovei, 2<sup>nd</sup> by David Dean to change Line Item A3120.2 Police Equipment from \$90,000 to \$105,000 for shared buy of Firearm Simulator.

Discussion: <u>Councilman Trovei</u> asked where the simulator will be kept and <u>Supervisor Spears</u> said the Port Jervis Police Department is building a range that will eventually be housed at the range, but could be used at anybody else's facility. Until the Port Jervis Range gets done, it will be housed in the Delaware Valley School and they've provided a room for it and any agency can use it. Mr. Trovei explained that it was good and would save on ammunition.

<u>Supervisor Spears</u> mentioned that on Page 11 under the Sales Tax A1120 – the years 2017, 2018 and 2019 there was no change, but this year they will take a tremendous jump around 1,102 to 1.2. He would like to increase that now and maybe increase it again after the Public Hearing to \$1,000,025. <u>Councilman Trovei</u> said it was awesome. Mr. Spears said they could provide residents with a 0% tax increase. Mr. Trovei would like to see 1.5% even more so, if they could get to the point where they could give back a quarter to half percent. They want taxes stable and to be very conservative. Discussion continued.

They are still working on a grant for moving the Police Station. He's still working on that. They hope it will provide \$100,000.

<u>Councilman Smith</u> said good job on the budget. People should be happy and he wished more people knew about it. Unless the word gets out there, they don't appreciate it or the sacrifices that were made.

Councilman Schock thanked the Supervisor for doing this because he just wonders how he does it.

Supervisor Spears added that the town got the \$125,000 grant to do more roads.
