RESOLUTION # 3 OF 2016 OF THE TOWN BOARD OF  
THE TOWN OF DEERPARK, ORANGE COUNTY,  
NEW YORK

WHEREAS, the Town of Deerpark, County of Orange, State of New York, is a municipal corporation in the State of New York; and

WHEREAS, the Town of Deerpark has the authority to control and regulate roads and highways within the Town; and

WHEREAS, one such road in the Town of Deerpark is named Troll Lane; and

WHEREAS, the said Troll Lane is a Private Road that passes from the Town of Deerpark, County of Orange, State of New York into the Town of Forestburgh, County of Sullivan, State of New York; and

WHEREAS, the name of the road changes from one municipality to the other, being known as Boulder Way; and

WHEREAS, it would be in the interest of the Town government, emergency personnel, U.S. Postal Service employees, as well as the residents of the road, to have consistency in the naming of the road; and

WHEREAS, the residents of the Town of Deerpark residing on Troll Lane have requested that the name of the road be changed to Boulder Way.

NOW, THEREFORE, BE IT RESOLVED, that the Town Board of the Town of Deerpark, County of Orange, State of New York, hereby changes the name of Troll Lane and renames the Private Road to now and hereinafter be known as Boulder Way; and

BE IT FURTHER RESOLVED, that the Clerk of the Town of Deerpark, County of Orange, State of New York, is hereby directed to send NOTICE of the change of road name to the Hon. Annie Rabbit, Clerk of Orange County, New York, Peter Misiaszek, the Postmaster of the Sparrowbush Post Office, and to Hon. Joanne Nagoda, Town Clerk of the Town of Forestburgh, Sullivan County, New York, within Ten (10) Days of the date of Resolution.


