RESOLUTION #6 OF 2016 **Abolish Elected Position of Office of Tax Collector**

WHEREAS, the Town of Deerpark, County of Orange, State of New York, currently has the elected position of Town Tax Collector; and

WHEREAS, JANE GARVEY was re-elected to a two-year term on November 3, 2015 for the period between January 1, 2016 and December 31, 2017 to the position of Tax Collector of and for the Town of Deerpark, County of Orange, State of New York; and

WHEREAS, JANE GARVEY has tendered her resignation from the elected position of Tax Collector effective January 1, 2016; and

WHEREAS, the Town Board of the Town Deerpark appointed a person to fill the position of Tax Collector of and for the Town of Deerpark until the next election is conducted to fill the position as of November 8, 2016; and

WHEREAS, the Town Board of the Town of Deerpark is desirous of exercising their authority pursuant to Section 36(1) of the Town Law of the State of New York to abolish the elected position of Tax Collector for the Town of Deerpark and to transfer the functions of that office as well as the authority and responsibility of collecting taxes to the Office of the Town Clerk of the Town of Deerpark.

NOW, THEREFORE, BE IT RESOLVED, that the Town of Deerpark, County of Orange, State of New York, hereby abolishes the elected position of Tax Collector by exercise of their authority pursuant to Section 36(1) of the New York State Town Law; and

BE IT FURTHER RESOLVED, that the functions, responsibilities and obligations previously performed and exercised by the Tax Collector of the Town of Deerpark are hereby relegated and assigned to the Office of the Town Clerk of the Town of Deerpark pursuant to Section 36(1) of the Town Law of the State of New York.






