**RESOLUTION #9 OF 2015 – CREATE COURT OFFICER POSITION**  
**OF THE TOWN BOARD OF**  
**THE TOWN OF DEERPARK, ORANGE COUNTY,**  
**NEW YORK**

WHEREAS, the Town of Deerpark has previously authorized and created the position of Court Officer to provide for an employee who serves to provide security in and for the Town of Deerpark Local Justice Court; and

WHEREAS, the Town of Deerpark has provided for formal firearm education and training for the proposed employee designated and appointed as Court Officer; and

WHEREAS, it would be in the best interest of the employees and citizens of the Town of Deerpark to permit the Court Officer charged with the security for the Local Justice Court to be permitted to carry a firearm in furtherance of his duties; and

WHEREAS, the Town of Deerpark employee designated as Court Officer IS NOT a uniformed court officer of the unified court system; and

WHEREAS, the Town of Deerpark employee designated as Court Officer IS NOT a New York State Civil Service Employee for purposes of CPL Section 2.10, Subdivision 21; and

WHEREAS, the Town of Deerpark desires to confer upon the said Court Officer employed by the Town of Deerpark the status of peace officer pursuant to and as defined in the provisions of CPL Section 2.10; and

WHEREAS, the Town of Deerpark has provided for, and the proposed employee designated and appointed as Court Officer has completed, formal firearm education and training.

NOW, THEREFORE, the Supervisor and Town Board of the Town of Deerpark, County of Orange, State of New York, hereby request that the Governor of the State of New York, the Senate of the State of New York, and the New York State Assembly, consider and approve Home Rule Legislation to be created and adopted by the Town of Deerpark, County of Orange, State of New York:

1. Designating the individual appointed to the position of Court Officer of and for the Town of Deerpark, County of Orange, State of New York, as a peace officer pursuant to and as defined in the provisions of CPL Section 2.10;
2. Conferring upon the individual appointed to the position of Court Officer of and for the Town of Deerpark, County of Orange, State of New York, the status of peace officer pursuant to and as defined in the provisions of CPL Section 2.10; and
3. Authorizing a duly appointed, and appropriately trained, Court Officer Employee in possession of a lawfully obtained pistol permit, issued pursuant to Section 400.00 of the Penal Law of the State of New York, to carry a firearm in the course of his employment and duties with the Town of Deerpark Local Justice Court.


