## RESOLUTION #19 OF 2015 STOP DWI PROGRAM

WHEREAS, drivers operating vehicles while under the influence of alcohol pose an extreme danger to and negatively impact the safety of New York's travelling public and its economy; and

WHEREAS, the Town of Deerpark has previously participated in and assisted with the Orange County Stop DWI program; and

WHEREAS, the Town of Deerpark has been notified that Orange County will again be running a Stop DWI campaign commencing Thanksgiving 2015 through Labor Day 2016; and

WHEREAS, Orange County has provided for the Town of Deerpark to receive up to Two Thousand Eight Hundred 00/100 Dollars (\$2,800.00) depending upon participation by the Town of Deerpark in Stop DWI events; and

WHEREAS, Orange County requires the Town of Deerpark to execute a contract with a corresponding Town Board Resolution in order to participate in the Stop DWI campaign and receive grant funds from the NYS Stop DWI Foundation.

NOW, THEREFORE, BE IT

RESOLVED, that the Town of Deerpark, County of Orange, State of New York, agrees to participate in the Orange County Stop DWI campaign for 2015/2016; and

BE IT FURTHER RESOLVED, that the Town of Deerpark, County of Orange, State of New York, agrees to accept funds provided by the Orange County Stop DWI/NYS Stop DWI Foundation campaign in exchange for the Town's participation in various Stop DWI events; and

BE IT FURTHER RESOLVED, that the Town of Deerpark, County of Orange, State of New York, authorizes Police Chief Richard J. Szyndor of the Town of Deerpark Police Department to execute the Inter-Municipal Agreement and related documentation in order to participate in and accept funds from the Orange County Stop DWI program/NYS Stop DWI Foundation.




